Operation Round Up supports many thanks to participating members

Operation Round Up, a charitable program unique to electric co-ops, is designed to provide financial assistance to non-profit or community-based organizations that demonstrate a commitment to enhancing the quality of life in the Minnesota Valley Electric Cooperative (MVEC) service area.

The primary source of funding for ORU is from MVEC members who voluntarily

round up their electric bills. MVEC employees also have the option to payroll deduct a monthly contribution.

Each quarter, members of the ORU trust board examine requests for funds and meet to determine funding. John Miller of Henderson is president and is joined on the board by Carolyn Christopherson of Belle Plaine, Connie Meeker of Green Isle, Pam Peters of Hamburg, Dick Peterson of Belle Plaine, Carol Ragan of Shakopee, Carol Schultz of Belle Plaine, Pam Weiers of Henderson and Jeanne Zwart of Elysian.

In 2018, a total of \$121,001 was given to 124 organizations within MVEC's service area. Since the program was implemented in 1995, over \$1.8 million has been donated.

\$1,000 scholarships available for high school seniors

The deadline to apply for a \$1,000 scholarship is Monday, Feb. 18, 2019. Graduating high school seniors attending public, private or home school are eligible to apply. Five recipients from each of MVEC's three districts will be randomly selected. The only requirement is to be a member of Minnesota Valley Electric Cooperative with a wish to further your education.

Applications are available at www.mvec.net/our-community. Winners will be recognized at MVEC's 81st Annual Meeting on April 9, 2019, at TCU Middle School in Le Center. MVEC scholarships are funded through Unclaimed Capital Credits — money that would otherwise be claimed by the state.

Basin Scholarship

Basin Electric, one of our wholesale power providers, has one \$1,000 scholarship available. An essay and an outside appraisal are required. The Basin scholarship deadline is also Monday, Feb. 18. The recipient is chosen by Basin Electric in April.

Youth Tour applications now open for free D.C. trip

Do you know a high school sophomore or junior in MVEC's service area who is interested in a trip to Washington D.C.?

One representative, whose parent or guardian is an MVEC member, will be selected to participate in the National Rural Electric Cooperative Youth Tour, to be held June 15-20, 2019.

A 300- to 500-word essay is due with the application by March 1, 2019.

An alternate will also be selected and will

receive a \$200 cash prize.

The winner will travel with approximately 40 Minnesota teens sponsored by other rural electric co-ops and be one of 1,500 national delegates.

Trip highlights include:

• Touring historical sites,

including Arlington National Cemetery, Capitol Hill, the Lincoln Memorial, Mount Vernon, the Smithsonian Institution, the U.S. Supreme Court, the Washington National Cathedral and more.

- Meeting local political representatives and learning more about government.
- Creating lifelong friendships with students from all around the country.

MVEC is sponsoring the trip as a commitment to education and learning the role electric cooperatives play in developing strong rural communities in America.



Solar array project will not move forward

MVEC's campaign to determine member interest in a cooperative-built solar array ended Oct. 31 with the results showing there is not enough member commitments to move forward. Out of the co-op's 42,000-plus members, approximately 200 subscriptions of 100-kilowatt hour blocks were received. To move the project forward, MVEC needed a member

commitment of 1,600

blocks.

Annual Meeting last April. Partnering with a group from the University of Minnesota, initial survey results indicated a large interest in a locally-sited Cooperative Solar array. However, when it came to firm commitments, actual participation did not materialize. Though MVEC strives to meet members' needs and interests, as a cooperative, we are tasked with using resources and funds with all MVEC

members in mind.

The renewable energy campaign did show that members are interested in supporting renewable energy through Renewable Energy Certificates (RECs). MVEC's GreenSource program features both

Wind and Solar RECs at affordable rates. For as little as \$1 a month for wind or \$3 a month for solar, the average MVEC household can offset its total electric usage with RECs. Information on the REC programs is available at www.mvec.net/renewables.

As a voluntary program, only members who sign up for RECs pay for the GreenSource program, not the membership as a whole.

MVEC remains committed to renewable energy and is on track to meet Minnesota's mandate of 20 percent renewables in our energy portfolio by the year 2020.

Thank you to the members who participated in the surveys and supported the project.


Directors represent the membership and work to establish policies, develop budgets and set rates.

Voting will take place by mail or at the Annual Meeting on Tuesday, April 9, 2019, at TCU Middle School in Le Center.
