TRY BEFORE YOU BUY – ELECTRIC FORKLIFT TRIAL

Electric forklifts have been material-handling workhorses for years. Recent technology and battery advances have boosted electric forklift performance, enabling them to compete with internal combustion counterparts indoor and out, all while delivering substantial energy and cost saving benefits over the useful life of the forklift.

This program is intended to be a partnership with the cooperative, the business member and the forklift dealer. Everyone needs to work together to provide the best solution to ensure the electric forklift meets operational requirements.

How it works

- This is a custom program option, generally structured as a short-term lease in lieu of a rebate. The short-term lease is used as a trial period for the business member to test out an electric forklift and experience how it fits their business needs.
- The cooperative, business member and the forklift dealer gather information on their existing forklift fleet and identify operational requirements of an electric forklift and to define what currently is working well with existing forklifts, as well as what could work better?

Program Requirements

- Member must have at least two eligible class 1 or 2 internal combustion forklifts that are operated for a minimum of 40 hours a week.
- Cooperative will pay a one-month rental (up to \$2,500) of a new electric forklift that has been determined by a participating cooperative's forklift vendor to meet or exceed the forklift's workload and duration requirements.
- Member is required to operate the rented forklift every workday for the duration of the rental period to assess the electric forklift activity.
- Member must agree to attend and participate in a kickoff and summary meeting with the forklift vendor and cooperative staff.

Additional Information

- If an electric forklift purchase or lease is made at the close of the Try Before You Buy rental period the electric forklift is ineligible for additional rebates.
- Subsequent adopted electric forklifts and high frequency charging will be eligible for a rebate.

General Rebate Program Rules

1. A contract or lease must be complete before funds are issued.
2. Members and vendors must submit a copy of the contract or lease, rebate application, and manufacturer equipment specifications.
3. This program is intended to be customizable to fit the needs of the business Member, forklift dealer, and cooperative. A cooperative representative must be involved with the project before the contract is signed to be eligible for this program.
4. Project must comply with all program specific rules and qualifications.
5. The member is responsible for checking with the cooperative to determine funding availability and to verify program parameters.

Electric Forklift

This program rebates short-term electric forklift leases that replace an internal combustion engine forklift. Qualifying electric forklifts must be operated a minimum of 40 hours per week. The program can be used in conjunction with the ETS charging rate and ReVolt renewable energy, but is not required.

Class 1: Electric indoor/outdoor forklifts	36 V, 48 V, or 80 V 3,000–12,000 lbs Lift capacity
Class 2: Electric indoor narrow-aisle forklifts	24 V, 36 V, or 48 V 3,000–5,500 lbs lift capacity
Class 3: Electric hand- or rider-truck – Ineligible	12 V and 24 V 3,500–8,000 lbs. lift capacity
