MVEC leaders recently traveled to Washington, D.C., to represent our member-owners at the National Rural Electric Cooperative Association (NRECA) legislative conference. We joined thousands of other electric co-ops to speak directly with Minnesota lawmakers about energy policies that impact communities like ours.

Reliable, Affordable Electricity

MVEC is focused on keeping power reliable and affordable. That means advocating for a balanced energy mix — including natural gas, coal, hydro, renewables, and nuclear.

We asked policymakers to support:

- **Permitting reform** that makes it easier to responsibly build essential electric projects
- **Balanced environmental regulations** that don't compromise reliability and affordability
- **Financing tools** for energy infrastructure upgrades
- **Federal programs** that strengthen the electric grid and support future growth

Why It Matters

Rising energy demand means we must plan ahead. Retiring older and reliable generation resources without ready replacements creates risk. That's why strong public policy and partnerships are critical.

Cooperatives Are Different

We reminded legislators of an important fact: MVEC doesn't have shareholders, **we have member-owners**. We are a not-for-profit organization.

As we advocate for our member-owners nationally, it is also important to collaborate locally and build partnerships to educate legislators on the cooperative difference.

Be Storm Ready

Severe storms can strike fast, bringing lightning, strong winds, and power outages. MVEC linemen are always on call and ready to act during a storm, and it's important you are prepared as well.

Emergency kit essentials

Stock essentials like flashlights with fresh batteries, a battery-powered radio, non-perishable food, a manual can opener, bottled water, medications, baby supplies, and blankets. Know where you will take shelter and plan multiple evacuation routes if needed.

Report your outage

MVEC's outage line is open 24/7 — Call 952-492-8255 or text 855-963-3830!

If you use the phone number associated with your account or text with your number listed in SmartHub, our system will automatically locate you. If you get an automated voice, you can always stay on the line to speak with a dispatcher.

Is your phone number up to date?


If you've traded a landline for a cell phone, make sure MVEC has your updated number — this helps with outage restoration. Be prepared and update your phone number at www.mvec.net/outage

Safety after the storm

- Stay alert for hazards.
- Avoid downed power lines — always assume they are live — and report them to 911 immediately.
- Never enter flooded areas where electrical equipment is submerged.
- Have any water-damaged appliances inspected before use.



Meet MVEC's \$1,500 scholarship winners!

MVEC has awarded twenty \$1,500 scholarships to graduating high school seniors this year. In addition, one \$1,000 scholarship was sponsored by MVEC's wholesale power provider, Basin Electric Power Cooperative.

Ella Barsness, a current sophomore at the University of Wisconsin–Madison, received this year's Basic Electric Scholarship.

Scholarship winners were randomly drawn from a total of 75 applications submitted across MVEC's three voting districts, with five students selected from each district. An additional five were drawn from high school seniors who attended the co-op's Annual Meeting on April 8.

MVEC scholarships are open to graduating high school seniors whose parents or legal guardians are MVEC members and are funded through unclaimed Capital Credits — money that would otherwise be given to the state.

MVEC also named its 2025 Youth Tour representative: Anne Marie Cline, a junior from Southwest Christian High School. Anne Marie will join students from across the country on an all-expenses-paid trip to Washington, D.C. this June to learn more about electric cooperatives and the democratic process in action.
