## Thankful for the power of community

Minnesota Valley Electric Cooperative is thankful for the opportunity to serve our member-owners and local communities with safe, reliable, and affordable electric service. You're not a customer — you're a valued member-owner. It was great to meet many of you in person during our District Member Meetings in October.

During the presentation, I shared some of the opportunities facing our cooperative today. Like all utilities, MVEC continues to navigate cost pressures from line material, equipment, and wholesale power costs, as well as diverse views on energy policy and the evolving electric grid. Through it all, **our commitment remains to deliver safe and reliable power that's affordable to every member we serve.** 

Our meetings featured a panel of MVEC team members from across the cooperative. They introduced themselves, described what they do each day to keep your lights on, and answered questions. We discussed what happens behind the scenes when an outage occurs, why it is important to keep your phone number updated in our system, and ways you can save through MVEC's Energy Wise® programs and rebates.

Over 43 percent of members participate in one or more Energy Wise® programs and enjoy an average savings of \$233 a year.

We also discussed MVEC's growth and were asked questions about renewable energy systems. Currently, there are 946 electric

vehicles installed in an Energy Wise program or time-of-use-rate, 518 member-owners with solar systems, and 10 member-owners with wind turbines. For those interested in a simple way to support clean energy, Renewable Energy Credits (RECs) remain an easy, affordable option.



We talked about one of the most tangible benefits of cooperative membership — Capital Credits. Because MVEC is not for profit, any revenue beyond expenses is returned to our member-owners in the form of Capital Credits. Last year, MVEC returned \$1.78 million, bringing the total returned to members to more than \$34 million since 1959.



# Be ready before the storm Winter outage preparedness


Minnesota winters bring heavy snow, ice, and wind, all of which can lead to power outages. Preparing beforehand will help you stay safe and comfortable if the lights go out.

When an outage affects more than 250 members, MVEC posts updates at www.mvec.net/outage and on our Facebook page. Click the dot near your location for more details.

### Additional safety tips

- · Use flashlights, not candles, for light.
- Keep refrigerator and freezer doors closed to preserve food.
- Dress in layers and gather in one room to stay warm.
- Avoid flooded areas and never touch electrical equipment if you're wet or standing in water.
- Stay away from downed or hanging power lines they may still carry electricity.
- Never drive over a downed line; report it immediately.
- If your vehicle touches a power line, stay inside until help arrives.

Who can run: MVEC members who live within the service area, are not employed by a competitor or energy supplier, and are able to attend monthly board meetings on the last Wednesday of each month.


Deadline to file: Midnight Tuesday, Jan. 27, 2026

### **Board of Directors approve updated district map**

MVEC is governed by a nine-member Board of Directors, three from each of the cooperative's three districts.

The Board recently determined that redistricting was needed to adjust district boundaries to ensure balanced representation across the service area. This prevents situations where one district grows disproportionately in population, larger than others, leading to uneven member-owner representation.

Recent growth in parts of MVEC's service area made these updates necessary to maintain fair and equitable governance.

The new map is shown above.

Our bylaws state in Article III - Directors, Section 1 General Powers of Directors and Director Districts: The number of members in any one (1) district may not vary by more than ten percent (10%) from the average number of members for the districts. At least once every ten (10) years, the Board of Directors shall conduct a survey to determine whether the number of members in a district has changed. If the number of members in a district has changed by fifteen percent (15%) or more, the districts shall be changed so that representation on the Board of Directors continues to be apportioned equally throughout the districts in proportion to its membership.
