CEO Update from Marvin Denzer

Tuesday, April 9, has a big red circle on MVEC's calendar because that is the date of our 87th Annual Meeting.

A lot of work goes into this meeting, but we are happy to do it for you, the member-owners we proudly serve.

I always look forward to our Annual Meeting evening

because it's a great opportunity for me, the Board of Directors, and our staff to talk with members and hear what's on your mind.

If you have not yet attended an Annual Meeting, we invite you to attend this year at Jordan High School. On behalf of our entire Board of Directors, Board President Deborah Erickson will host the approximately hour-long event. We will have informative video reports from each area of the co-op to give updates about the investments and projects of the past year. Randy Erdman, Vice President of Finance, will give an update on MVEC's financial condition, which includes operating margins and Capital Credits – money returned to you, our member-owners.

We also will introduce our 2024 Washington, D.C., Youth Tour participant and will present 18 - \$1,500 high school scholarships (funded by Unclaimed Capital Credits) – including three scholarships to be drawn from registered high school seniors attending the meeting with their parents.

Spending time with you and hearing your take on MVEC's energy future is important to us because everything we do is planned with members in mind. The energy landscape is shifting rapidly, and we anticipate you may have questions. Member needs and changing

2024 Construction Work Plan

In 2024, your cooperative will make an investment of around \$16 million in MVEC's electric grid system. These construction budget dollars are spread over the co-op's 968-square-mile service area to increase reliability and power quality and to provide general maintenance for MVEC's 46,000+ members in portions of nine counties. Below are some of our largest projects once construction season begins.

1. Our largest project of the year is a complete rebuild of the Prior Lake substation. This includes updating the control house and high side structures and will take up nearly one quarter of the work plan budget.

2. Replace and update nearly 8 miles of line north of Henderson.

3. Relocating line to make way for a Highway 212 expansion near Norwood. This will increase reliability by updating aged line.

4. Moving line underground in Chaska, as part of a large infrastructure project the City is undertaking.

5. A single phase copper rebuild near the Le Center substation. This replaces old wire to improve reliability and outage response.

6. Rebuild high side structures at St. Thomas substation due to old switches. Upgrade to 3-phase line for safety and reliability south of St. Thomas substation.

7. On opposite ends of MVEC's service area, feeders will be replaced to improve backfeed capability at our Cleveland and Zinran substations.

8. Relocating our feeders underground to make way for a Highway 169 overpass near MVEC's Merriam substation, north of Jordan. Depending on the timing of the project, MVEC may have a similar project near our St. Lawrence substation, south of Jordan.

Know What To Do



In an auto accident with power lines

- Do not leave the car. Warn passersby to stay safely away.
- Call 911 to have MVEC notified.
- Stay in the car until a utility professional has told you it is safe to exit.
- The only reason you should leave the vehicle is if it is on fire. In an emergency, jump clear of the vehicle with your feet together (without touching it and the ground at the same time), and continue to **hop away with your feet together** as far as you can.

Calling all students!

Basin Scholarship

Basin Electric, our wholesale power provider, has a \$1,000 scholarship available for high school seniors and college undergraduates. This scholarship recognizes academic and community achievements and includes an essay question and teacher/counselor recommendation

In order to apply for either of the Basin or MVEC scholarships, applicants must:

- Be a graduating high school student
- Have a parent or legal guardian that is an MVEC member
- Attend public, private, parochial, or home school
